5. THAPgroup has the right to inspect any product inventory or equipment.
6. Vendors agree to sell only the items listed on this agreement in the description field. No transfers or sub-agreements are allowed.
7. Vendor agrees this agreement is exclusive to them only. Termination of this agreement will occur if any of the following appear:

 - c. Vendor selling or products/services not outline in agreement.
